

Terms of Use

These Site Terms create an agreement applicable to your use of our services at the Site. If you do not agree to be bound by these Site Terms, you may not access or otherwise use the Site.

We depend on you for accurate information

When registering on our site and global game jam event, we assume that the venue information you provide is correct and you have the right authority to carry out an event.

We reserve the right to suspend or terminate your application for any reason, although we are unlikely to do that as we want to have fun and enjoy the event as much as you do.

As our events are run by local volunteers, decisions by the local venue may vary such as entry costs, policies, waivers. As such the requirements of each location are subject to local policies.

Creative Commons and Collaboration

We built our site with the intention of allowing our community to share and collaborate together. As such we actually encourage sharing but also want to encourage a common brand for our event.

Elements of the Site, including page headers, custom graphics, logos, sounds, images and button icons, are part of our branding and welcome for use in promoting our event.

You may not use, frame or utilize framing techniques to enclose any Global Game Jam trademark, logo or other proprietary information (including the photographs and images found at the Site, the content of any text, audio/visual programming and/or the layout or design of any page of any of the Site) without the GGJ directors' express written consent. Further, you may not use any meta tags or any other "hidden text" embodying or containing the name, trademark, or product names of the GGJ without GGJ's express written consent.

In most cases we will give you instant permission; we simply want to ensure that we do not create misleading information. Global Game Jam strives to be unbiased and not favor any particular region or venue over another.
